

**RESOLUTION NUMBER 2015-07-27-R**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PRINCETON, TEXAS, ORDERING AN ELECTION TO BE HELD ON NOVEMBER 3, 2015, FOR THE PURPOSE OF ELECTING A MAYOR AND TWO (2) COUNCILMEMBERS TO THE CITY COUNCIL, ONE FOR PLACE NO. 1, AND ONE FOR PLACE NO. 2, AND TO HOLD OFFICE FOR A PERIOD OF TWO (2) YEARS; AND ORDERING A SPECIAL ELECTION TO BE HELD ON NOVEMBER 3, 2015 FOR THE PURPOSE OF ELECTING ONE COUNCILMEMBER TO THE CITY COUNCIL FOR PLACE NO. 4 TO FILL THE UNEXPIRED TERM BEING A PERIOD OF ONE (1) YEAR; DESIGNATING LOCATION OF POLLING PLACE; ORDERING NOTICES OF ELECTION TO BE GIVEN AS PRESCRIBED BY LAW IN CONNECTION WITH SUCH ELECTION.**

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PRINCETON, THAT:**

**Section 1.**

An Election is hereby ordered to be held on Tuesday, November 3, 2015, for the purpose of electing one Mayor and two (2) Councilmembers, one for Place No. 1, and one for Place No. 2, to fill the expiring terms on the Princeton City Council, and each such term being for a period of two (2) years and a Special Election to be held on Tuesday, November 3, 2015, for the purpose of electing one (1) Councilmember for Place No. 4 to fill the unexpired term being for a period of one (1) year,

**Section 2.**

The polling place where qualified voters shall cast ballots at such location in the City of Princeton 2015 regular & special municipal election is as follows:

Election polls shall be open from 7:00 AM until 7:00 PM on the date of the Election.

**Section 3.**

Early voting by personal appearance shall be available weekdays in the City Secretary's Office, City Hall, 123 West Princeton Drive, Princeton, Texas 75407 beginning on Monday, October 19, 2015, through Friday, October 30, 2015, during the normal working hours of 8:00 AM until 5:00 PM except for Saturday, October 24, 2015 from 7:00 A.M. until 7:00 P.M. and Sunday, October 25, 2015 from 1:00 P.M. until 6:00 P.M. and except for the week of Monday, October 26, 2015 thru Friday, October 30, 2015 and voting hours for this week will be from 7:00 A.M. until 7:00 P.M. Early voting by personal appearance shall also be available weekdays at the Collin County Sub-Courthouse, 2010 Redbud Blvd., Suite 102, McKinney, Texas 75069.

**Section 4.**

Applications for ballot by mail shall be received and processed by the Collin County elections Administrator, 2010 Redbud Blvd., Suite 102, McKinney, Texas 75069. The first day to apply for ballot by mail is September 4, 2015. Applications for ballots by mail must be received (not postmarked) no later than the close of business on Friday, October 23, 2015.

**Section 5.**

The City Secretary is hereby authorized and directed to publish and/or post, in the time and manner prescribed by law, all notices required to be so published and/or posted in connection with the conduct of this Election.
